SOUNDS Academy believes that the zip code of a child should not dictate their access to music education. Our mission is to teach, mentor, and provide musical experiences and opportunities to underserved youth. The vision of SOUNDS Academy is to provide music education opportunities to a wide variety of children while removing any barriers that children may have in receiving quality music education.</p>

Beyond students experiencing a live performance, musicians share their stories and speak about the importance of creativity, leadership, perseverance, resilience, teamwork, and higher education.
