Soup kitchen in Tbilisi, Georgia provided two hot meals per day to the elderly and refugees in the city

USAID Food for Peace IFRP provided \$90,000 in cash and \$444,683 in dehydrated soup (150.08 metric tons). It cost us \$49,543 to send 2 shipments of soup to Georgia in 2018. The rest of the money was spent on a storage facility in Georgia to store the soup until it was used, salary for the grant managers and a stipend to the Georgian responsible for overseeing the soup kitchen locally. We served 8,000,000 meals 2018 to 10,427 individuals in Tbilisi.

Georgian Diabetic Children Education Camp which is privately funded provides diabetic (type 1) Georgian children with medical supplies and a fun, safe educational program whereby they learn to manage their diabetes. This camp was held for 1 week at a nature camp site. This year we had 47 kids attend. The campers were supervised by counselors and medical personnel.
