All such persons and entities shall be eligible for consideration as a grantee of the Foundation.

No representative of the Foundation shall derive any direct or indirect benefit from the selection of a particular grantee. The board of directors shall have the authority to review all grants to ensure compliance with this provision. The Foundation will keep all records relating to all grants to individuals, including:

- a. Information obtained to evaluate grantees,
- b. Identification of grantees, including any relationship sufficient to make the grantee a disqualified person,
- c. Amount and purpose of grant, and
- d. Follow-up information, including required annual reports and investigation of jeopardized grants.
